## INVITATION FOR BIDS

- 1. Laljhadi Rural Municipality, Office of Rural Municipal Executive, Shankharpur, Kanchanpur invites Electronic Bids *for LAL-21-2077/078: Construction of Laljhadi Park*. Bidding is open to all eligible as per Section V of bidding document under National Competitive Bidding Single Stage Two Envelope Bidding procedures.
- 2. Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: *NRs* 108477000.00
  - Minimum Work experience of similar size and nature: *at least one Contract (Landscaping work) within the last ten (10) years, each with a value of at least NRs.* 33748260.00 *that have been successfully or are substantially completed.*
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at theOffice of Rural Municipal Executive, Shankharpur, Kanchanpur or may visit <u>www.laljhadirmnc.gov.np</u>& PPMO website <u>www.bolpatra.gov.np</u>.
- A complete set of Bidding Documents may be purchased from the Office of Rural Municipal Executive, Shankharpur, Kanchanpur by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Rs. 5000.00 till 2078/03/31 (15<sup>th</sup> July, 2021) during office hours.
- 6. Bidders should submit their bid electronically from PPMO's e-GP system i.e. <u>www.bopatra.gov.np/egp</u> & should deposit the cost of bidding document in Nepal Bangladesh Bank, Chandev Branch in ga 1.1. Antarik Rajasow Khata 0770001241.
- 7. Pre-bid meeting shall be held at LRM at 2078/04/21 (5th July, 2021), 12:00 Noon.
- 8. Electronic bids must be submitted to LRM through PPMO's e-GP system <u>www.bolpatra.gov.np/egp</u>on or before 12:00 noon on**2078/03/31((15th July, 2021).** Bids received after this deadline will be rejected.
- 9. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 noon on 2078/03/31((15<sup>th</sup> July, 2021)at LRM. Bids must be valid for a period of 90 of days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format amounting to a minimum of 1,266,000.00, which shall be valid for 30 days beyond the validity period of the bid (*i.e.*, 120 days)
- 10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
