Sealed bids must be submitted to the office Laljhadi Rural Municipality, Office of Rural Municipal Executive, Shankharpur, Kanchanpur by hand or through e-GP system i.e. <a href="www.bopatra.gov.np/egp">www.bopatra.gov.np/egp</a> on or before 12:00 on 2077/08/08. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2077/08/08 on 14:00 at Laljhadi Rural Municipality, Office of Rural Municipal Executive, Shankharpur, Kanchanpur.
- 7. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security mentioned above which shall be valid for 30 days beyond the validity period of the bid.
