Sealed bids must be submitted to the office Laljhadi Rural Municipality, Office of Rural Municipal Executive, Shankharpur, Kanchanpur by hand or through e-GP system i.e. [www.bopatras.gov.np/egp](http://www.bopatras.gov.np/egp) on or before 12:00 on **2077/12/06 (March 19, 2021)**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2077/12/06 (March 19, 2021)** on 14:00 at Laljhadi Rural Municipality, Office of Rural Municipal Executive, Shankharpur, Kanchanpur.
