Laljhadi Rural Municipality, Office of Rural Municipal Executive, Shankharpur, Kanchanpur [LRM] invites electronic bids from Nepalese eligible bidders for the construction of **LAL-18-2077/078: Road maintenance work at ward no 1,3 & 4** under National Competitive Bidding procedures. The estimated amount for the works is Rs. **2,499,599.34 (Exclusive of VAT and Contingencies)**.

A complete set of Bidding Documents may be purchased from the Office of Rural Municipal Executive, Shankharpur, Kanchanpur by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Rs. **3,000.00** till **2078/01/05** during office hours.

Bidder should submit their bid electronically & may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) & should deposit the cost of bidding document in Nepal Bangladesh Bank, Chandev Branch in ga 1.1. Antarik Rajasow Khata 0770001241.
5. Electronic bids must be submitted to the office LRM through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00:00 on 2078/01/06**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00:00 on 2078/01/06** at the office of LRM. Bids must be valid for a period of 90 after bid opening and must be accompanied by a scanned copy of the bid security in .pdf format, amounting to a minimum of NRS. **74,000.00**, which shall be valid for 30 days beyond the validity period of the bid (i.e., 2077/05/06)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
